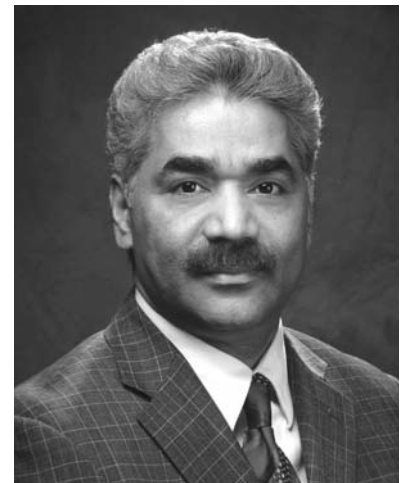

# MINISTRY EFFECTIVENESS

## Master's Touch Ministry

- 59 men graduated Master's Touch Program
- 14 men completed "Designed for a Work"
- 36 graduates found full-time jobs
- 9 men reconciled with wife or family
- 88 men made professions of faith in Christ
- 27 men promoted to full-time resident assistants
- 5 men promoted to Resident Staff
- 8 men resided at our discipleship house - Horizon

## Lifespring Ministry

- 69 women and 79 children served, a total of 36 families served
- 12% of women completed the program
- 15% made a profession of faith or rededicated their life to Christ
- 89% showed remarkable improvement in communications skills
- 81% showed remarkable improvement in parenting skills
- 20% received professional counseling
- 65% of Phase III clients obtained jobs
- Currently have contact with 22% of alumni

## Urban Youth Ministry

- After-School Tutoring: 60 kids at Brady Elementary School
- Aurora Neighborhood Baseball League: 120 at-risk youth
- 60 elementary and junior high aged kids attended summer camp
- Coats for Kids - more than 300
- Toy distribution - more than 300
- Easter basket distribution - 200

## Hope Outreach

- Up to 55 men at one time were provided daily, real-life work experience in our warehouse, transportation department, maintenance shop, and Hope Chest Resale Store
- 7 ministry vehicles maintained with an average of 5,300+ miles per month
- Scheduled, transported, sorted, and refurbished over 350,000 donated items including clothing, furniture, household goods and other miscellaneous objects. These items were sold at the Hope Chest Resale Store or distributed to under-resourced men, women, and children in the community or within one of Wayside's ministries
- Provided 230 families in the community with furniture, clothing, and other basic needs through our Community Outreach program
- Assisted local churches with 129 referrals for clothing, housewares and furniture
- Collaborated with World Relief in Aurora to provide clothing and housewares for 86 refugee families
- 100+ winter coats were distributed to needy families and individuals through a partnership with the city of Aurora and the Aurora Public Schools
- 660 bales at 700 lbs. each of clothing and 1100+ bags of shoes at 40 lbs. each were recycled with the majority of those items going to third world/developing countries
- Partnered with 15 local churches to host Compassion Drives with the purpose of collecting clothes, furniture, and other household items that could be used in our Hope Chest Resale Store as well as other areas of our ministries
- Proceeds from our Hope Chest Resale Store along with our income from recycling clothing, shoes, and scrap metal totaled \$503,541 all of which went to fund the ministry efforts at Wayside Cross Ministries

## New Life Corrections Ministry

- Our Dads' Classes, Bible Studies, Literature Distribution and one-on-one counseling continued weekly in the Kane, Kendall, McHenry & DuPage County Jails, the Fox Valley A.T.C., Stateville Prison, and the IL Youth Center in St. Charles
- We completed our 20th 2-Day Dads' Seminar in the IL State (men's) Prisons
- 884 men graduated from our Dads' Classes Course (270 in 2011)
- 114 Chaplains and Volunteers attended our two 1-Day Training Seminars (65 in 2011)
- 27 Chaplains and Volunteers attended our two 5-Day Chaplain Training Academies
- 192 Volunteers are involved (150 in 2011)
- Arranged for 112 prison inmates to come to the Master's Touch program after their release (70 in 2011)
- Chaplain Tom welcomed Mike McClelland "on board" as a part-time Office Assistant
- Chaplain Tom welcomed his first great-grandson (Tom, 4th) into the world!

## Elgin Wayside Center

- 62 individuals placed in supportive housing or permanent residency
- 16,598 warm meals served
- 148 NEW individuals received service from Wayside this year
- 66 volunteer hours served on average each week
- 34% increase in guests served on a daily basis
- 780 Bible studies taught by volunteers

## DuPage Initiative

- Fill in gaps in the daytime services provided to the homeless by giving shelter and food to at-risk guests
- See homeless guests transition to life-change programs or sustainable housing

## BRIDGE TO LIFE CAPITAL CAMPAIGN UPDATE

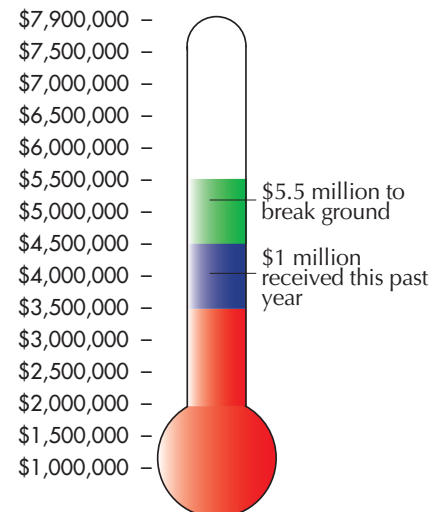
From the Spring of 2009, Wayside Cross Ministries has been prayerfully raising funds to provide a new facility for the Master's Touch ministry and WCM's offices in downtown Aurora with the Bridge to Life Capital Campaign. BTL seeks to provide a new facility with areas for personal counseling, additional support staff and programming to serve the Master's Touch men's ministry.

In the past year we've reached \$4.5 million of the goal of \$7.9 million – an addition of \$1 million in the past year. Please continue to pray along with us for this important need.

A construction committee is in place and ready to move forward with building con-

struction as soon as an additional \$1 million in Campaign funds are raised. We are currently pursuing major funding through New Market Tax Credits, a Federal Housing loan and from a major local foundation. We are even closer to breaking ground today because of the enthusiasm and generosity of WCM's faithful supporters. We are very thankful for the response to the Campaign thus far.

# ANNUAL CAMPAIGN UPDATE

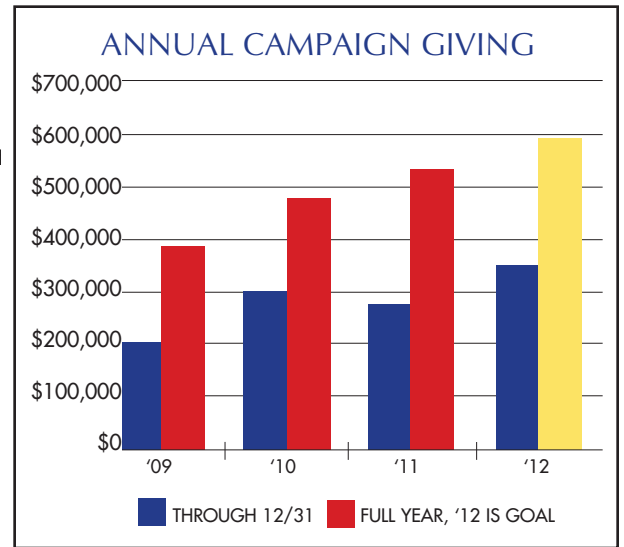

they have for the last 84 years. We cannot thank them enough"

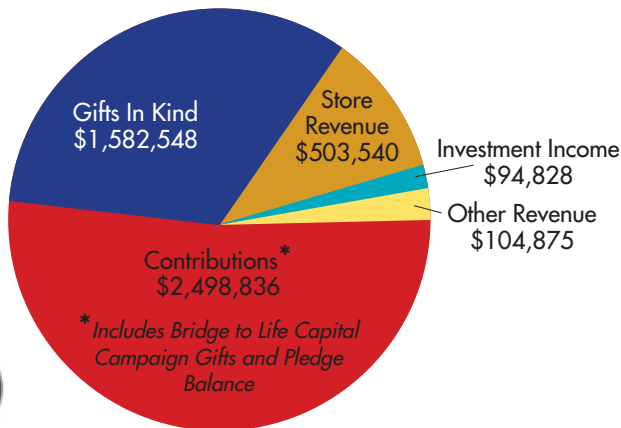

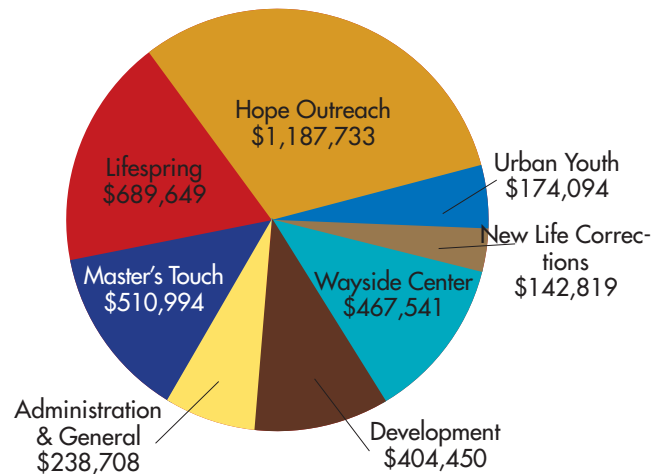

# MINISTRY UPDATES

## Donation Bins

Wayside Cross Ministries is always trying to reach out in new ways to create opportunities that engage our surrounding community and benefit those that are in need. This year we have taken on a new challenge and jumped into the crowded "Donation Bin" space. You may have seen several different donation bins all around the area whether in the parking lot of your local grocery store or major big box retailer. Knowing that this area of the resale and donated goods industry was already filling up we decided to go a different route and approach some of our long-term partner churches in the local area.

When this process began we knew that the bins themselves would have to be very high-quality in order for this to be successful. As you may have seen with some of the other bins they can be poorly constructed and fall a part in a short amount of time, or they end up being an eyesore. Eventually we were able to

get in touch with a company on the east coast in the business of manufacturing recycling containers. After a long process and some interference by Hurricane Sandy we finally received our shipments of the initial 5 bins and are thrilled with the high level of quality put into these units.

We are very thankful to the churches that were willing to take this step with us and we are currently looking for more churches that would like to discuss this opportunity. Currently we have bins located at Christ Community Church (St. Charles & Blackberry Creek campuses), The Compass Church (Hobson campus), and Twin Oaks Baptist Church in Sleepy Hollow. Donations can be dropped off at any time if you are near one of these locations. Currently we are only accepting donations of clothing and shoes at the bins. # WCM ALUMNI ACHIEVERS JOURNEY

What happens to men who complete the Master's Touch program? From the experience of hundreds of men we understand that their success includes building on a good foundation, with prayer, close fellowship with a healthy church and the encouragement of believers in their lives.

They enjoyed a good breakfast, prayed together, heard from four Master's Touch graduates and an encouraging message about building on the solid foundation of Christ, "Everyone who hears these words of mine and puts them into practice is like a wise man who build his house on the solid rock." (Matthew 7:24)

The testimonies expressed appreciation for the role WCM played in their lives as the means

God used to transform them. The remarkable help of counselors and mentors, timely and Christ-centered teaching, and earnest prayer all combined to begin their journey of transformation through the grace of God.

On this morning everyone agreed their transformation began at WCM, and their journey since then includes challenges. One man related a lesson he'd learned from Executive Director James Lukose at a final lunch James hosts for the graduates. "If or when you fall in the future, will you fall forward or backwards?" This has stuck with the graduate ever since – the advice, fall forward!

Alumni Achievers Journey is built on WCM's desire to stay connected with graduates and encourage them. And we would like the graduates to stay connected with WCM and pray for the ministry they benefited from. Transitional Services Coordinator Dan Olson was instrumental in this first gathering and promised another event during the upcoming year.

During a recent visit to Pacific Garden Mission in Chicago Dan Olson and Executive Director James Lukose were very pleased to learn that four men – graduates of WCM's Master's Touch program – are on fulltime staff at the Mission. We bless the Lord for continuing to bless the lives of these men.

Wayside Cross Ministries is committed to working alongside each resident to address all of the areas essential for their future success and transitional plans. The primary objective is that each graduate be fully equipped when they leave WCM. There are eight areas essential for the successful transition to independent living.

- Home Church Attendance
- Driver's License, State ID, Social Security Card
- Resolving Outstanding Issues with Courts
- Establishing E-mail Contact Information
- GED, Certifications, College Planning
- Bank Account and Money Management
- Resume and Interviewing Skills
- Pursuing Employment Opportunities

He Who Began a Good Work

– Philippians 1:6

My name is John. I came to Wayside Cross Ministries and the Master's Touch program three years ago from prison, and the Lord used it to change my life.

In prison I heard the gospel and through God's grace I was saved, but that was only the beginning of my story. I soon learned that the Lord Jesus wanted my whole life, and he wanted a real commitment to the new life of salvation. My past was a mess but the Lord had saved me and would work in my life.

I entered the Master's Touch program, graduated, and stayed on to work at WCM. Today I am a Resident Coordinator for the Master's Touch program, helping men like me learn how the Lord Jesus can turn their lives around.

One of the toughest things to deal with is rebuilding a life filled with the sins of the past, but I know the Lord wants me to take care of



this. With the help of Transitional Services Coordinator, Dan Olson, we've started to rebuild my life. Just this year we've:

- Began repaying debts to the State of Illinois (will be done by year's end)
- Will begin repaying federal student loan (no longer in default)
- Paid off past traffic tickets in another state
- Began the process to reinstate my Illinois driver's license
- Started a savings account at a local bank
- Stayed committed and involved with my church, Covenant of Grace OPC in Batavia

My past problems are very common for men who look for a new life through the help of the Master's Touch program. With the help of Mr. Olson, I'm learning what it means when the Lord says, "Being confident of this, that he who began a good work in you will carry it on to completion until the day of Christ Jesus" – Philippians 1:6.

John is grinning ear to ear with joy because he just passed another hurdle in rebuilding his life.

He received word that he is eligible to get his drivers license reinstated.

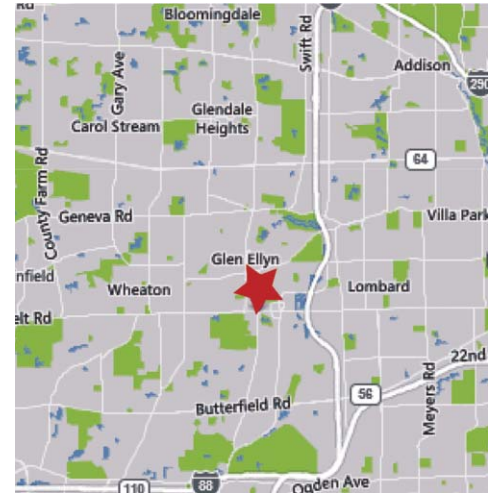
# DUPAGE INITIATIVE

Larger than 300 square miles, DuPage County becomes a pretty huge place when you are homeless. Most people without housing just want to hide. They don't enjoy being spectacles and they don't necessarily want to bother anyone. By and large, they are exhausting their time, energy, and resources just traveling from one night shelter to the next. Many are kept homeless because of joblessness and many are jobless because they are homeless. Lack of transportation, coupled with the unpredictability of nighttime shelter, inability to get a good rest, and growing gaps in employment do not make them particularly attractive to employers in a challenging job market.

Wayside Cross Ministry's DuPage Initiative is an attempt to fill in some of the gaps that exist in the lives of the homeless. Working alongside area churches, PADS, and organizations that have opened their hearts and doors on

weekends and evenings, the DuPage Wayside Center is offering daytime shelter two days per week during the most critical months of the year (November thru March). Meeting at Peoples Community Church in Glen Ellyn, volunteers serve meals and snacks, lead Bible studies, offer biblical and professional counseling, as well as provide a safe environment to rest.

During the first weeks of the DuPage Initiative dozens of the area's homeless participated in Bible studies, were served meals, and received hours of counseling and case management. The coldest months are the most dangerous and the number of homeless in need of services increase. Our goal, Lord willing, is to eventually provide a year-round ministry among our homeless neighbors in DuPage County.
